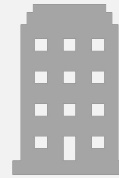

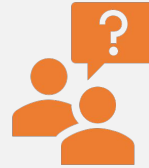

A system that ensures all timbers harvested, transported, manufactured from Indonesia come from legal sources and in full compliance with the Indonesian laws.

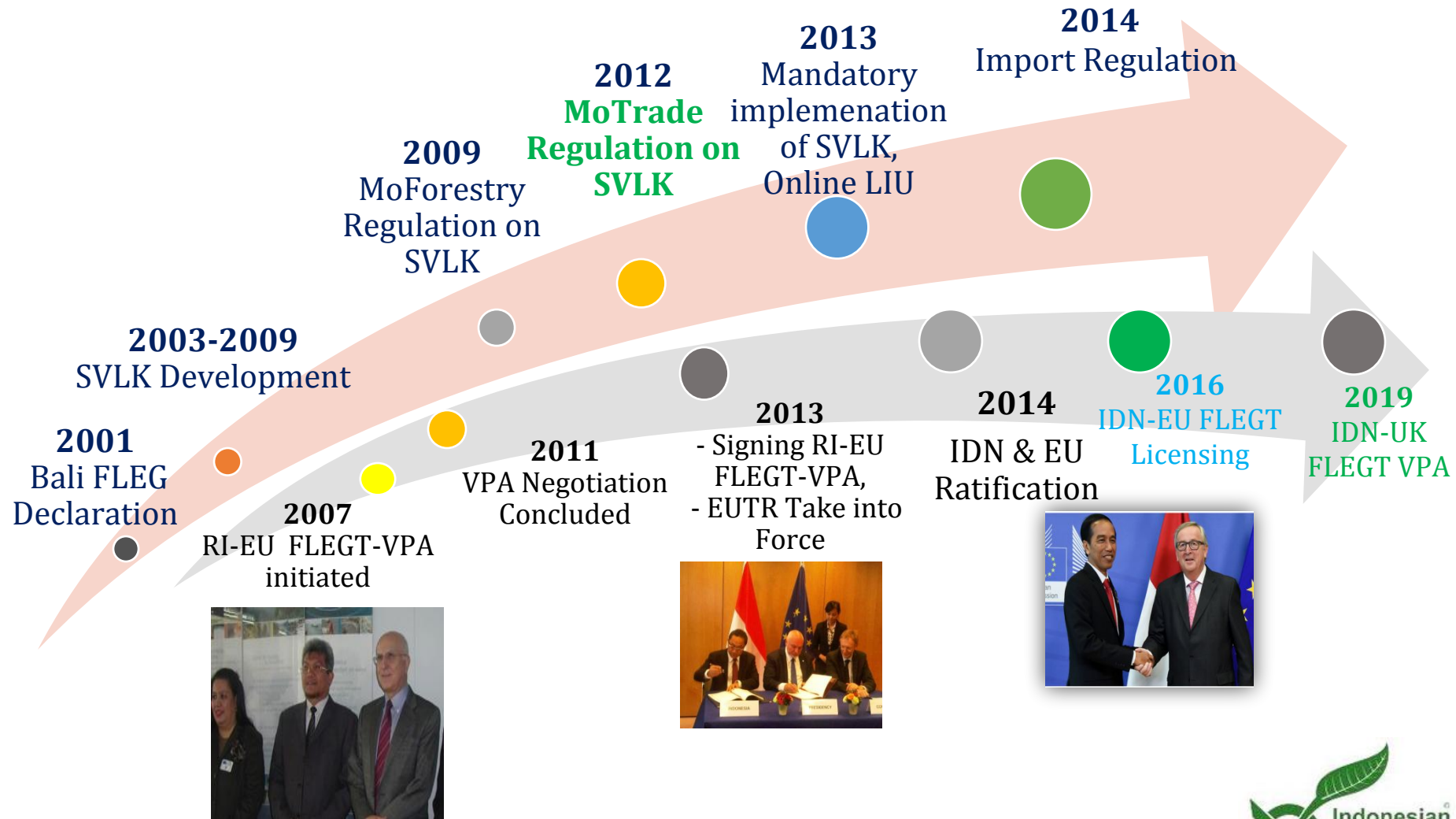


The scope of the system covers all the spectrum of timber production, including forest management units, timber industries and timber depots.

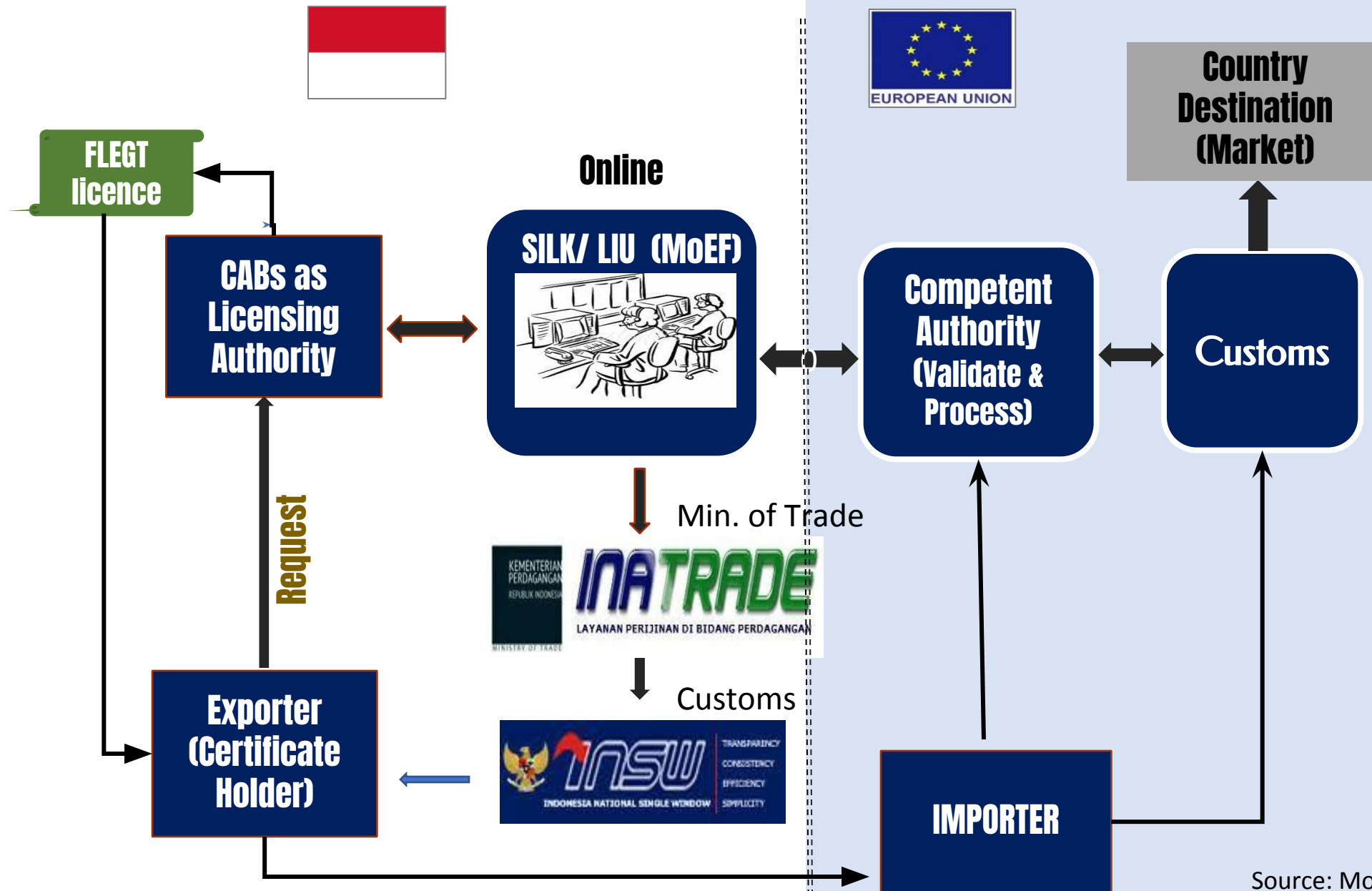
Scope of SVLK

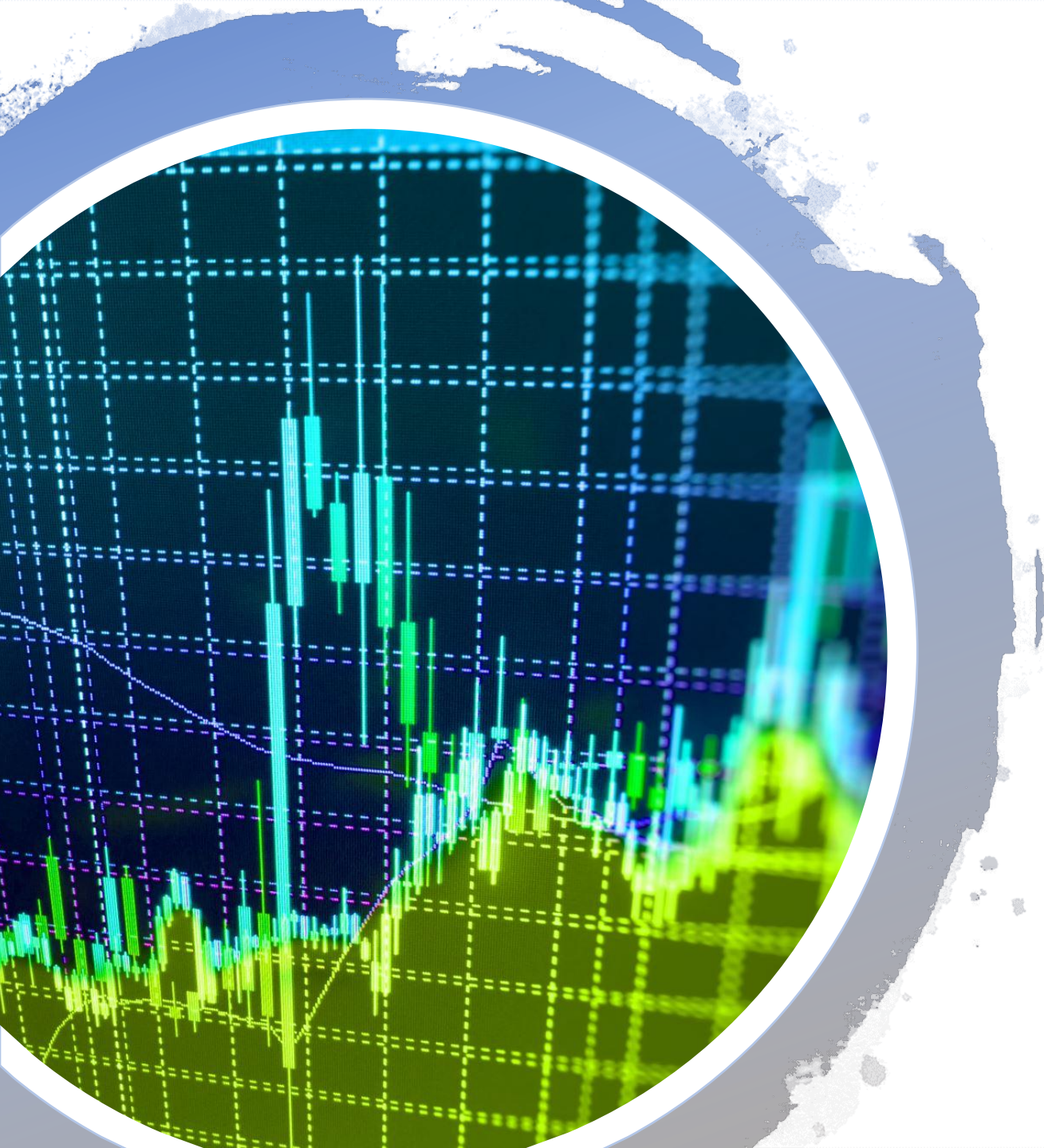

1. Is a timber product export license document and become guideline of prohibited and/or restricted goods (Lartas)
2. Valid for 51 groups of HS-Code
3. Issuance by LVLK (24 institutions)
4. Issued for each invoice/transaction, for producer exporters/traders who already have S-LK
5. Data element: LVLK identity (name, address, accreditation number), Importer Identity (name, address, importing country, loading port, loading port and value (Special sheet 4-7)), Number, expiration date, export country and code, transportation, exporter identity (name, address, NPWP), description of goods, HS code, trade name and scientific name, country of origin of raw materials and code, volume (m3) weight (kg), number of units, signature and LVLK stamp, barcode)

Some Progress

- 26 Conformity Assessment Bodies have been accredited by the National Accreditation Committee
- Majority of companies/auditees (on and off forests) are becoming **more acceptive/ cooperative/ supportive**
- **>23 Million hectares of forests and more than 4200 Wood manufacturers have been certified since 2010**
- **CSO-consortium** (as an independent monitoring body) **is actively monitoring**
- **Since January 2013 to May 2019, more than one million legality documents have been issued for exports of timber products with a total value > USD 54 billion to world markets**
- Formal recognition by EU since 15 November 2016 as first FLEGT-Licensing country, Acceptance by Australia under *Illegal Logging Prohibition Act (ILPA)* since 2014, IDN – UK FLEGT VPA in 2019

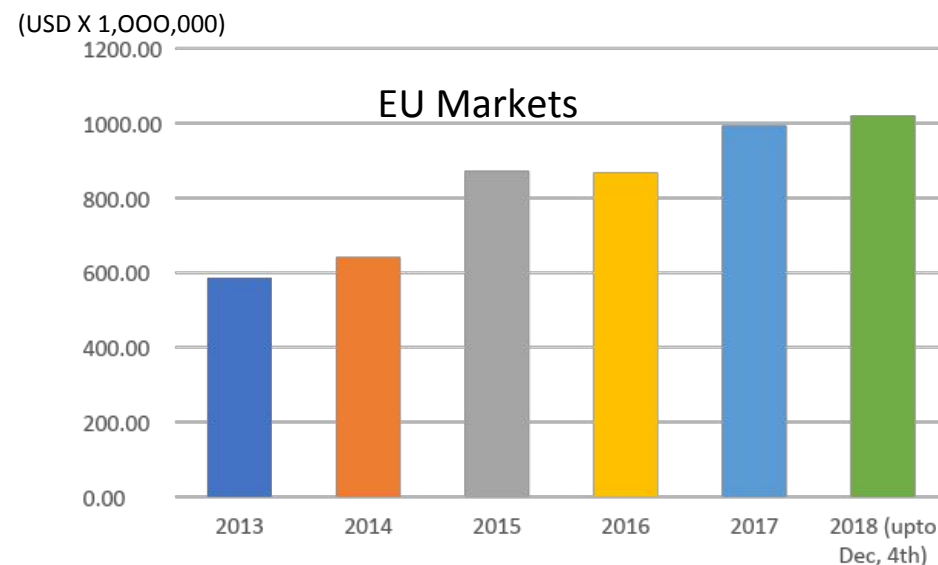
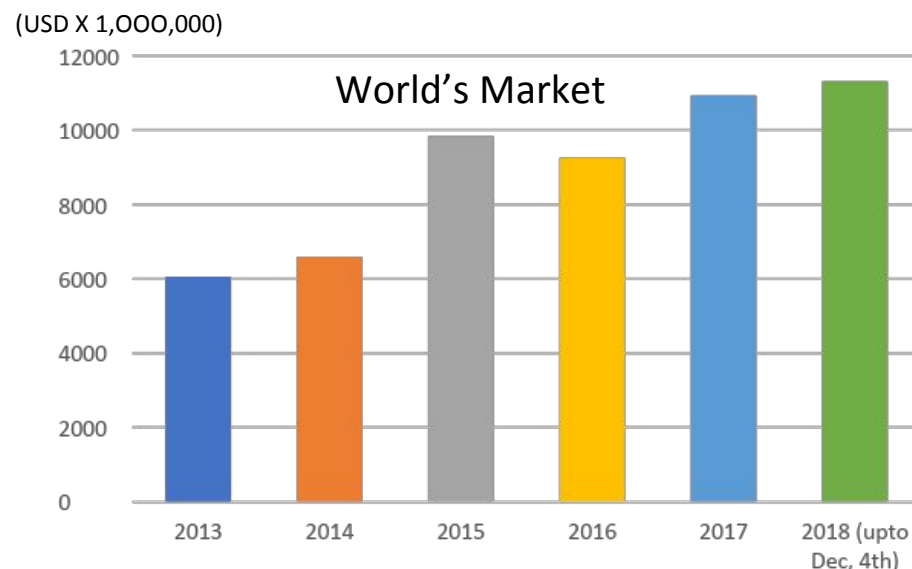

- EU's imports of tropical wood products from Indonesia increased 7% in the first 6 months of 2018
- Indonesia's share of EU's tropical imports increased from 15.7% to 16.6%
- Indonesia may benefit more from stricter enforcement of EUTR

Since January 2013 – more than 934 000 shipments of certified timber and wood products to the worlds market (>USD 54 billion), including > 80 thousands FLEGT licensed shipments to the EU markets (> USD 2.5 billion) since 16 November 2018.



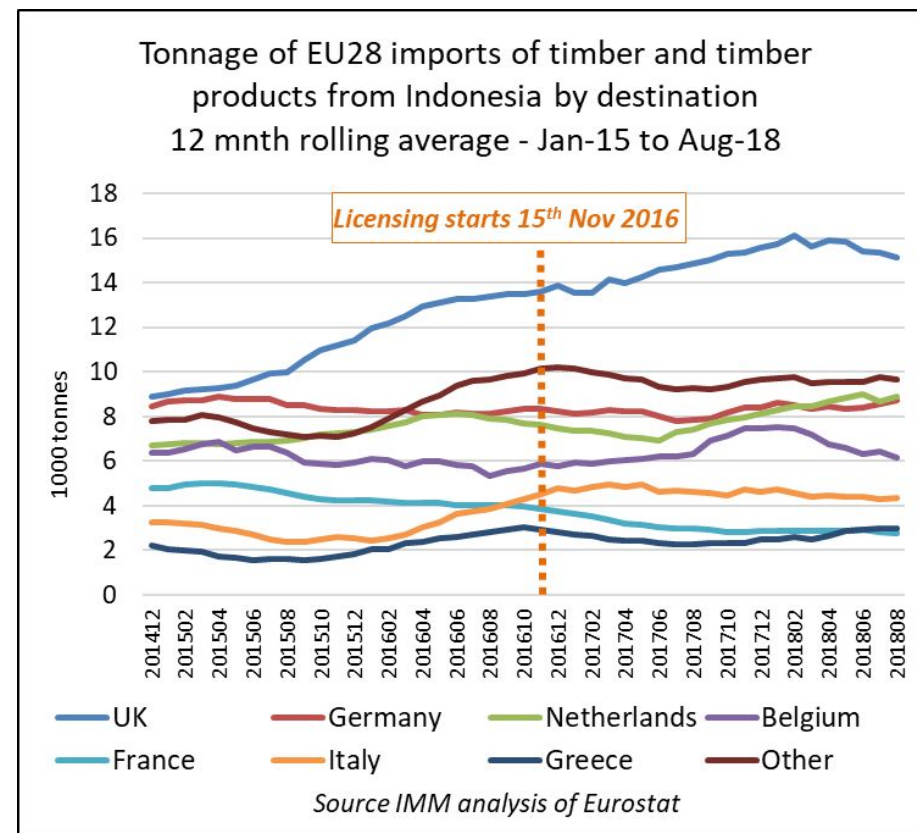
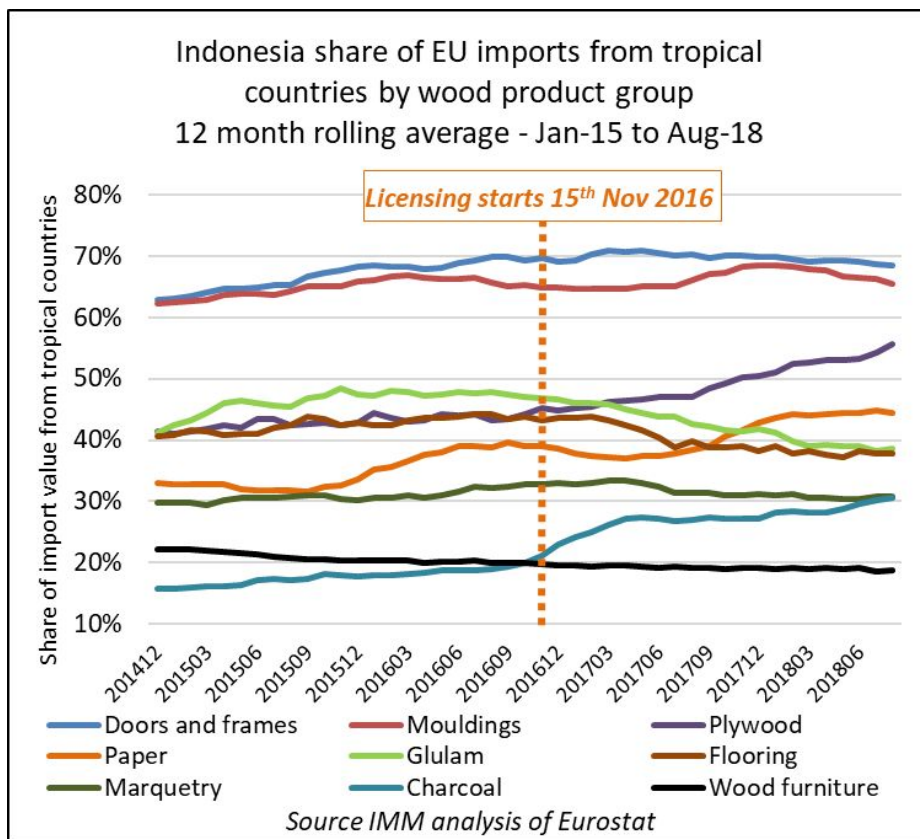

FLEGT Licensing Issues

- Up to November 2018, nearly 393 cases (+/- 0.52 %) has been reported
- Some technical issues:
 - HS Mismatch (107 cases),
 - Data discrepancies between FLEGT licenses and other documents (76 cases),
 - Incomplete information on FLEGT licenses (27 cases),
 - Format/appearance issues of FLEGT licenses (36 cases),
 - other cases (license expired— 6 cases, Duplicate – 5 cases),
 - Export without FLEGT License or Shipments arrived before FLEGT licenses,
 - FLEGT licenses issued for products not under VPA, etc
- HS Mismatch - Switch from HS 4409, 4412 and 4418 to 4407 is found in 85% of cases.
